### Notice of Third Public Meeting Nelson WWTP Complex Infiltration/Inflow Pilot Rehabilitation Project

Dear Property Owner:

Johnson County Wastewater (JCW) invites you to participate in the third public meeting to discuss sanitary sewer improvements in your neighborhood (the area in Prairie Village bound approximately by West 75<sup>th</sup> Street on the North, West 79<sup>th</sup> Street on the South, Delmar Street on the East, and Juniper Drive on the West). The public meeting will be held on **Thursday, September 29, at 6:00 pm beginning with a one hour open house forum followed by a 30 to 45 minute presentation at 7:00 pm, at the Prairie Baptist Church, 7416 Roe Avenue** (see map on back).

If you cannot attend this meeting, a similar meeting will be held on Wednesday, September 28, at 6:00 pm at the Shawnee Town Museum in the Town Hall Building, 11600 Johnson Drive.

The Johnson County Board of County Commissioners recently approved funding for this construction project and selected Wiedenmann & Godfrey Construction, Inc. to perform the construction work through a competitive bid process. Representatives of JCW, our consultants, and Wiedenmann & Godfrey Construction, Inc. will be present at the meeting to discuss the project. **Residents will have the opportunity to meet the project team, ask questions, and learn about the construction phase of this project, including the neighborhood impacts, restoration, and anticipated construction schedule.**

The public meeting will begin with an open house forum for informal individual discussion with the project team followed by a formal presentation.
