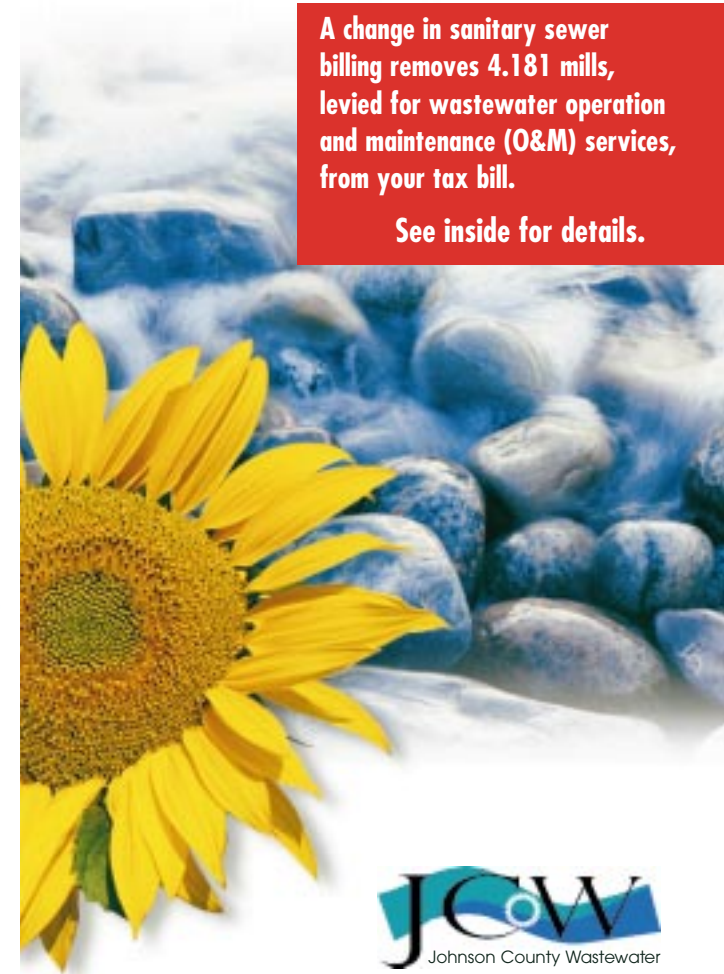

Wastewater Treatment & Your Taxes

*Changing the Way You
Pay for JCW Services*

**A change in sanitary sewer
billing removes 4.181 mills,
levied for wastewater operation
and maintenance (O&M) services,
from your tax bill.**

In the past, your operation and maintenance (O&M) charges for wastewater services were based on your property value and were included on your tax bill. Beginning in January, a direct billing system for sanitary sewer services based on average winter water use will provide a fairer way of collection and removes 4.181 mills levied for wastewater O&M services from your tax bill.

Why is the wastewater billing process changing?

Improving fairness and removing the wastewater O&M mill levy from your taxes are reasons why JCW is implementing a billing system change effective in January 2003.

How will I pay for wastewater services in the future?

Wastewater charges will no longer be based on the value of your property. Now, the user charge on your wastewater bill will be based on your average winter water usage for residential customers (and actual monthly usage for commercial and industrial customers). Septic tank users are not obligated to pay JCW for sewer service.

How does this affect my property taxes?

The elimination of 4.181 mills from this year's county tax bill for wastewater operation and maintenance (O&M) costs is a direct result of this billing change.

Will I see any other wastewater-related charges on my property tax bill?

YES. A separate wastewater charge for capital expenditures (generally not related to day-to-day operation) will remain on your tax bill. These fee-generated funds will be used to cover the cost of capital expenditures that could include structures, improvements, equipment and other major assets including land.

How are new wastewater fees calculated?

Residential service charges are determined by multiplying average winter water usage by a pre-determined rate and then adding a service charge to that amount. JCW sets a rate that, when applied to this formula, generates funds necessary to recover the wastewater operation and maintenance costs only.

JCW will annually review operational costs and make rate adjustments accordingly. Adjustments will be based on measurable data such as changes in the economy, prices for chemicals, gas, electricity, etc. used in the operation of wastewater facilities.

Do I have to do anything to initiate this new wastewater billing change for my residence?

NO. The change to a user-based billing system for your wastewater services will be a seamless transition for you. Bills automatically will be sent to JCW customers.

When will I receive the new billing statement?

JCW bills will be mailed to residential customers every other month (or six times per year) beginning in January. Commercial and industrial customers will be billed on a monthly basis. Statements will be mailed in envelopes clearly marked with the JCW logo.



What is the difference between my water bill and my new Johnson County Wastewater bill?

Charges from JCW are for the safe and efficient transport of wastewater **from** your home and the treatment of that water before returning it to area creeks, lakes and rivers. Your water company bills you for the water that comes **into** your home for drinking, cooking, bathing and watering your lawn.
